

### Disclaimer: SBD Good Neighbor Program

SBD Good Neighbor Program Noise Report presents noise monitoring information managed by the SBD Good Neighbor Program. SBD International Airport has no authority over the movement of aircraft or the direction of flight. The authority to regulate flight patterns of aircraft is vested exclusively in the Federal Aviation Administration (FAA). FAA air traffic controllers have the responsibility for directing aircraft on the ground and in flight, and the pilot in command has the final authority as to the safe flight of her/his aircraft. Pilots in command make the final decisions relative to runway use; therefore, pilots may request to use any available runway. Neither the airport nor the FAA air traffic controllers may restrict a pilot's access to an available runway.



















### **Final Thoughts**

There was a slight <u>decrease</u> both in noise comments received and distinct households filing in **1Q21** compared to **4Q20**, attributed to:

• Seasonal shift in cargo lift operations: from the busier year-end holidays to a reduced schedule in the New Year and early spring.

\*\*\*

There was an <u>increase</u> in noise comments received in **1Q21** compared to **1Q20**, attributed to:

- Growth in aircraft operations and based and transient operators year-over-year, and
- Enhanced community education and awareness of the Good Neighbor Program.

\*\*\*

SBD's overall noise comments remain considerably lower than at any other commercial service airport in California.

Airport staff continue to focus on efforts to educate pilots on neighborhood noise sensitivity. The Good Neighbor Program brings awareness and information to the community about airport activities and developments and promotes two-way communication.
